**ORDER**

On the 8<sup>th</sup> day of August, 2012, came the parties by their respective Counsel, and the Defendant having entered pleas of “XXXXXXX” to the felony offenses of “XXXXXXX” under Count One of the Indictment, “XXXXXXXXXXXXXXXXXX” under Count Two of the Indictment, and XXXXXXXXXXXXXXXXXXXXXXXX” under Count Three of the Indictment, and it having been **ORDERED** by the Court that both a Psychiatric and a Psychological examination is appropriate and necessary, it is further hereby **ORDERED** as follows:

- 1) The Division of Forensic Psychiatry, Chestnut Ridge Center, 930 Chestnut Ridge Road, Morgantown, West Virginia 26505, will conduct all necessary psychiatric evaluations in order to render an opinion about the Defendant’s diagnosis and offer an opinion regarding sexual offense risk factors.
- 2) The XXXXX County Prosecuting Attorney shall confer with the Division of Forensic Psychiatry to schedule an appointment for the examinations.
- 3) The authorities at the Northern Regional Jail and Correctional Facility will transport the Defendant to and from his appointment with the Division of Forensic Psychiatry, Chestnut Ridge Hospital, 930 Chestnut Ridge Road, Morgantown, West Virginia 26505, on the \_\_\_\_\_ day of \_\_\_\_\_, 2006, at \_\_\_\_\_ o’clock . For an appointment scheduled to last for an approximate time of \_\_\_\_ hours.
- 4) The Court further **ORDERS** that, upon receipt of an original invoice and a court order with a raised seal of the Clerk of this Court, the West Virginia Department of Health and Human Resources Office of Behavioral Health Services shall pay for the initial examinations pursuant to West Virginia Trial Court Rules, Rule 35.05. The original invoices and the Court Order shall be forwarded to the Assistant Director of the Office of Behavioral Health Services at 350 Capitol Street, Room 350, Charleston, West Virginia 25301.

The completed reports for all examinations shall be forwarded to The Honorable Judge, XXXXXXXX County Courthouse, Moundsville, West Virginia 26041, with a copy of the same provided for XXXXXXX, Esquire, Attorney for the Defendant, XXXX XXXXX Jr. At the Public Defender Corporation, 607 Court

Avenue, Moundsville, West Virginia 26041, and to XXXXXXXXXXXX, Esquire, Prosecuting Attorney for Wetzel County, at Post Office Box 548, New Martinsville, West Virginia 26155.

It is so **ORDERED**.

It is further **ORDERED** that the Clerk of this Court transmit an attested Copy of this order to the Defendant,XXX XX Jr., by and through his Attorney, XXXXXXXXXXXX, Esquire, of the Public Defender Corporation; to the Northern Regional Jail and Correctional Facility who is responsible for transporting the Defendant to and from his appointments as set forth herein; to the Division of Forensic Psychiatry, Chestnut Ridge Hospital, 930 Chestnut Ridge Road, Morgantown, West Virginia 26505; and, to XXXXXXXXXXXX, Wetzel County Prosecuting Attorney.
