General Peds requirements according to ACGME:

*Ambulatory Experiences

The level of supervisory responsibilities in the outpatient clinic will progressively increase from PGY 1 to PGY 3. The other major ambulatory experience will consist of a minimum of 36 half-day sessions per year of a longitudinal outpatient experience that provides a medical home which focuses on wellness and prevention, coordination of care, longitudinal management of children with special needs and chronic conditions, and provide a patient- and family-centered approach to care. Also, during the community Peds rotation, it is planned that residents spend some time in PGP clinic, but during their 3rd year, also share coverage for PICU night shifts along with PACC residents.

**Subspecialty Rotations

The residents will choose subspecialty rotations by consultation with their mentors. The ACGME Requirements are as follows (Please note that not all subspecialty rotations are available at WVU):
